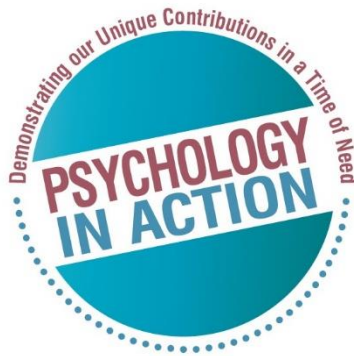

EXHIBITOR INFORMATION

ASSIGNMENT OF EXHIBIT SPACE

Assignment of exhibit space will be made according to the date and time the Oklahoma Psychological Association received the application. Speaker Gifts, Lunch, and Break sponsors receive priority space. Special consideration will be taken when assigning exhibit space regarding competing businesses.

SPONSOR AND EXHIBIT CONTRACT

The enclosed application for sponsorship / exhibit space and full payment together constitute a contract between parties. To reserve space and conference program logo and listing, applications and payments are due by September 1, 2018.

CANCELLATION

Sponsorships cannot be cancelled, but a sponsor can forgo exhibit space. Conference registrations can be transferred to another person in the same company for the same event.

INSTALLATION, EXHIBIT HOURS AND DISMANTLING

Tabletop exhibit space will be available Friday, November 2, 2018 – November 3, 2018 at the Northeastern State University Broken Arrow Campus Conference. Exhibitors will setup on Thursday, November 1 after 6 p.m. or before 8 a.m. on Friday, November 2, 2018. It is strongly encouraged to be in attendance during registration on Friday, November 2 to greet the attendees.

SPONSOR INFORMATION
